Conditions of Booking

1. Liability. No liability shall attach to Lakeside Park in respect of any loss or damage or injury suffered by any applicant or by any member of his/her family.
2. Young Persons. Bookings cannot be accepted from young persons under 21 years of age, or all male or all female groups.
3. Late Bookings. If a booking is made 28 days or less from the date the holiday is due to commence, the full remittance must be sent with the booking application form. For last-minute bookings please telephone Lakeside Park.
4. Disturbance. The applicants (being the persons listed on the application form), undertake not to do on their part or permit to be done by persons under their control anything which may in the opinion of the Management of Lakeside Park be or become a nuisance or annoyance or which shall in any way interfere with the peace or general comfort of other guests. Anyone committing a nuisance contrary to the peace of the Park will be asked to leave immediately and without refund. The Management's decision is final.
5. Unauthorised Persons. Only applicants shall be entitled to occupy the accommodation allocated for their use and any breach of this condition shall entitle the Company to terminate the booking and to exclude forthwith from the Park both the unauthorised persons and the applicants themselves. Upon such termination the applicants and unauthorised persons shall be deemed to be trespassers. No booking will be accepted by group parties or organisations.
6. NO COMMERCIAL VEHICLES under any circumstances. Cycles and scooters confined to cycle lanes where provided.
